## CONTRACT OF AGREEMENT

**THIS AGREEMENT** executed on the 24<sup>th</sup> day of March 2025 between **MOUNTAIN PROVINCE STATE UNIVERSITY** (hereinafter called the "Entity") and **TOYOTA DAGUPAN INC. – TOYOTA LA UNION BRANCH** (hereinafter called the "Supplier").

**WHEREAS**, the **MOUNTAIN PROVINCE STATE UNIVERSITY** invited bids for particular items of goods under the project title "**SUPPLY AND DELIVERY OF SERVICE VEHICLES**" and has accepted a bid by the Supplier in the amount of **SEVEN MILLION FOUR HUNDRED NINETY – SEVEN THOUSAND PESOS (P7,497,000.00)** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of this Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 and shall be deemed form part and be read and construed as integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning**

In consideration for the sum of **SEVEN MILLION FOUR HUNDRED NINETY – SEVEN THOUSAND PESOS (P7,497,000.00)** or such other sums as may be ascertained, **TOYOTA DAGUPAN INC. – TOYOTA LA UNION BRANCH** agrees to execute the contract **“SUPPLY AND DELIVERY OF SERVICE VEHICLES”** in accordance with his/her/its Bid.
4. **TOYOTA DAGUPAN INC. – TOYOTA LA UNION BRANCH** agrees to bind itself in behalf of the Entity to enable the performance of all standing warranty on all the items delivered respectively, under this Contract within the period expressly provided by the manufacturer and covered by the terms and conditions set by the same;
5. The **MOUNTAIN PROVINCE STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

**IN WITNESS** whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.



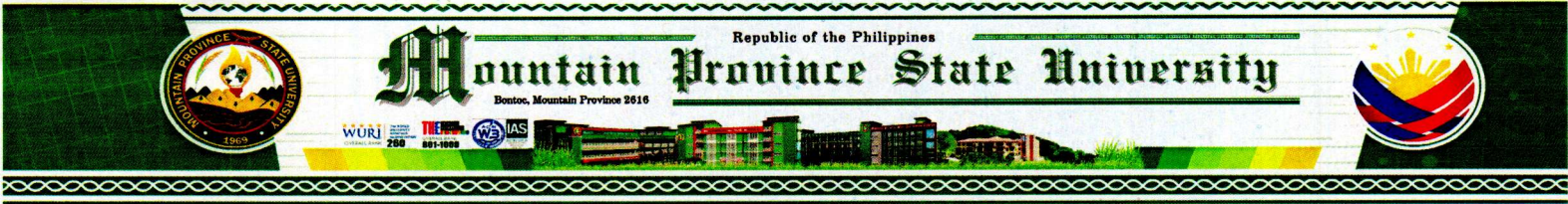
