CONTRACT AGREEMENT

THIS AGREEMENT, executed this 29th day of June, 2026 between **MOUNTAIN PROVINCE STATE UNIVERSITY** (hereinafter called the "Entity") and **YCHONGLIYAN CONSTRUCTION** (hereinafter called the "Contractor").

WHEREAS, the **MOUNTAIN PROVINCE STATE UNIVERSITY** is desirous that **YCHONGLIYAN CONSTRUCTION** executes the contract "**INSTALLATION OF ROOFING/ IMPROVEMENT AT THE ROOF TOP OF THE ADMINISTRATION BUILDING**" (hereinafter called "the Works").

WHEREAS, the **MOUNTAIN PROVINCE STATE UNIVERSITY** has accepted the Bid amounting to **FOUR MILLION, ONE HUNDRED TEN THOUSAND, SIX HUNDRED TWENTY-FOUR AND SIXTY-SIX CENTS (P4,110,624.66)** by the Contractor for the execution and completion of such Works and including the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the **MOUNTAIN PROVINCE STATE UNIVERSITY** through its **BIDS AND AWARDS COMMITTEE's** bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning**

3. In consideration for the sum of **FOUR MILLION, ONE HUNDRED TEN THOUSAND, SIX HUNDRED TWENTY-FOUR AND SIXTY-SIX CENTS (P4,110,624.66)** or such other sums as may be ascertained, **YCHONGLIYAN CONSTRUCTION** agrees to execute the contract **"INSTALLATION OF ROOFING/ IMPROVEMENT AT THE ROOF TOP OF THE ADMINISTRATION BUILDING"** in accordance with its Bid.
4. The **MOUNTAIN PROVINCE STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

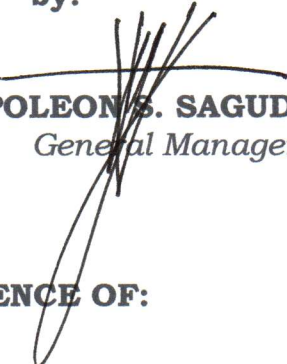

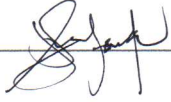
